

BME CO-LOCATION: Fees 2025

A) <u>Prices applicable to housing services</u>

Rack rental:

- 1 Rack: EUR 6,250.75 per month
- Half Rack: EUR 3,750.45 per month

Installation:

- EUR 2,500.30 per rack

Infrastructure supporting the connection:

The rental charge for the Racks includes the pertinent basic infrastructure supporting the connection, with the allocation of two 1 Gbps ports each and the related cabling. THE ENTITY may request the following extensions to the basic infrastructure, which shall be chargeable at the following rates:

- The allocation of a new pair of 1 Gbps ports (copper) (main and backup): EUR 1,875.23 per month.
- The upgrade from 1 Gbps copper connection to 10 Gbps fibre connection. This implies an add-on fee of EUR 1,750.21 per month per pair of connections (main and backup).

B) Prices applicable to connection services

- Connection to SIBE-SMART: EUR 2,200 per month.

This fee shall be applicable to any ENTITY that is a Member of one of the Spanish Stock Exchanges or that is a client of such Member with a sponsored access service. This charge shall be billed for each connection established, i.e. for each connection maintained by THE ENTITY with the Market (SMART-SIBE) both for its own direct operations and for each third-party entity housed in the DPC, in whose name THE ENTITY may operate. The applicable fees to a client of a Member of a Spanish Stock Exchange for the case of sponsored access, shall be billed to such Member.

This fee includes the pertinent basic infrastructure supporting the connection with the allocation of two 1 Gbps ports each, and the related cabling.

C) <u>External connectivity (Remote Access)</u>:

- Connection with facilities belonging to the ENTITY outside the Data Processing Centre shall be responsibility of the ENTITY.



D) <u>Prices applicable to connection services – cross-connects with other</u> <u>Entities and carriers:</u>

- Copper: EUR 625.08 per connection (one off)
- Fibre: EUR 1,250.15 per connection (one off)

(fees for additional patch panels will be quoted separately on demand)

Monthly:

- EUR 150 per cross-connect between THE ENTITY's rack and its telecommunication line provider's rack at the DPC and between THE ENTITY's rack and other entity housed at the DPC.

E) Installation and maintenance of the ENTITY's GPS Equipment (if required):

- Installation: EUR 755.08 one off
- Housing of GPS Equipment: EUR 125.02 per month

F) Housing of the equipment belonging to the ENTITY's Client (if any):

- Hosted User Fee per Client (*): EUR 625.08 per month.
- Connection per Client: separate connections per Client will need to be set up:
 - a. Additional pair of 1 Gbps port (main and back up): EUR 1,875.23
 - b. Upgrade from 1 Gbps connection to 10 Gbps connection: add on fee of EUR 1,750.21 per month.

(*) Clients are required to meet BME Co-location service requirements, same as the ENTITY.

G) Rates applicable to technical support services:

The fees for the technical support are shown in the table below. The cost of these interventions will be billed on completion subject to acceptance of the service, based on the time, schedule and materials employed.

H) Equipment Storage

Monthly fee for the rental of a shelf of 180x60x50 cm: EUR 350 (not prorated).

ENTITIES with uninstalled Equipment outside its rack at BME DPC over 6 days, will be assumed as to have rented a shelf, and the above monthly fee will apply. Such uninstalled Equipment will remain in any case under the responsibility of THE ENTITY.
